

2021.08.29 Nuremberg Code Violation Notice- Letter from Great Barrington

August 29, 2021

Dear All-

As promised, I am writing to share some thoughts and resources. I appreciated the inspiring speeches that each of you gave in defense of Freedom today at the NY State capital in Albany, and I was honored to shake each of your hands. Like unique flowers we each have roles to play and strengths to share. It has been my belief that with strength comes dharmic responsibility- if one can lead then they must! If one is blessed with financial resources then, much like the Founding Fathers of the American Revolution, they are compelled to risk everything for Liberty.

The documents that I attach were first shared with the School Committee which serves Great Barrington, Massachusetts. They are "Nuremberg Code Violation Notices" and will hopefully find use with you and your constituents. They were "served" on each member individually rather than on the Committee as a whole. Please share them as widely as you can so that they may stimulate Action. Some may complain that it is "inappropriate" to mention Nuremberg; it's too extreme or provocative. They favor a "loving," conciliatory, diplomatically measured approach to communication. I can only suggest that they read Dr. Martin Luther King's "Letter from a Birmingham Jail." I would suggest that humanity is, with the ever more totalitarian lock downs etc., in Jail.

There is a world-wide mesmerization taking place, and it is increasingly clear to those with eyes to see, ears to hear, hearts to feel, brains to think, and tongues to speak that we must be more provocative. Ghandi's salt march to the sea was provocative; MLK led many provocative initiatives. We cannot win this war by "Defending Freedom" from attacks on it. We must take the offensive. As a veteran, my experience tells me that scattered pockets of patriots will have little chance of ultimate victory over a determined foe which can marshal all of the resources of the State. It goes without saying that attempting to take the offensive with aggressive force of arms, intentional riot, destruction of property, etc. is not the way.

Have no doubt, a new society will result from the ashes of the current conflict. The State knows that the next few weeks and months will be decisive, and that is why it is so aggressively focused. If there is extensive post "vaccination" carnage in the upcoming normal flu season it will disrupt their plans; better to get everyone "vaccinated" first. It is my firm belief that Nuremberg is being violated and individuals and entities need to be truthfully Notified. That seems to be an essential first step. What happens thereafter is in God's hands. Will the wrong doers resign or repent? Will they be shunned by their communities? Will the judicial system function as it should, or will "citizen" councils or media hear evidence and render judgment? Will it be left to the Divine to punish?

This first action was specifically on masking with Notice served to the local School Committee. I have attached for your interest a very biased newspaper account of this which will provide real world context for this action. I hope that you will widely disseminate the two (.docx) documents which may be used as templates. Hopefully, other groups such as employees facing mandatory "vaccinations" may use these templates to customize their own Nuremberg Code Violation Notices. For instance, three of us are currently working on a Notice to the local hospital for "vaccination" of a senior citizen without informed consent. Notices are being prepared for pharmacies as well. Media that support falsehoods are also complicit and will be so notified. It is past time to act, and it is becoming evident that it is very difficult for individuals and entities to ignore these Notices.

Dear School Committee Member,

As you know, millions of parents around the country have major concerns about Covid-related health policies directed at children attending public schools, especially masking policies. At the outset, I wish to voice my appreciation for the personal sacrifices associated with volunteer public service such as yours, and the expertise that each of you brings to what is an essential—and sometimes a thankless—task. You have been entrusted with the great responsibility for the care and education of our children, as well as the well-being of teachers, staff, parents and volunteers who are involved in school activities.

The purpose of this letter and its attachment is to acquaint you, if you are not already aware, of international codes of humanitarian behavior (e.g., the Nuremberg Code) that must be respected when experimental medical procedures are imposed on children, such as the required wearing of masks throughout the school day. If you continue to enforce mandates that require the wearing of masks, I believe that you will be in violation of the Nuremberg Code. For that reason, I have attached a notice of violation to this email. Please understand that your individual harmful actions or failures to act may not be protected under the umbrella of committee membership and participation, even if these actions have been authorized by the MA Department of Education or some other administrative or regulatory body. As an individual, it is your responsibility to adhere to the humane practices required under the Nuremberg Code and similar codes intended to protect the integrity of human beings.

At a minimum, I would respectfully suggest that all masking mandates be suspended pending further study and public review of the risks and benefits. You are also reminded that informed consent must be requested of the parents who are the legal guardians of these minors in your temporary care, and that parents have a right to refuse to allow their children to be masked as a condition of attending public school.

Again, I deeply appreciate your public service. We all share the goal of providing a safe and supportive educational environment for our children. I raise these difficult issues because the physical and psychological well-being of children is at stake. I hope that you receive this letter in the spirit of collaboration that I offer it.

NOTICE is hereby given that you may be complicit in the violation of one or more of the provisions of the Nuremberg Code (see reverse side), a ten-point statement that limits permissible medical treatment and experimentation on human beings in accordance with generally accepted moral, ethical, and legal concepts. The Nuremberg Code was formulated following WWII to address cruel and harmful actions carried out by the Nazis; violations of the Nuremberg Code constitute **Crimes Against Humanity**.

It is strongly urged that you and your fellow members on the School Committee immediately review the actions that may be contrary to the Nuremberg Code (see list of Possible Violations below), and cease those actions—or failures to act—that violate the Code. Notice is further given that the excuse of “just following” recommendations, policies, procedures, orders, regulations, mandates, laws, ordinances, etc., is not a legitimate defense under the Code; your personal acts and/or failures to act that violate the Code are considered deliberately willful and indefensible, and are therefore subject to legal action.

Possible Violations of the Nuremberg Code (Provisions may be referenced as: NB1, NB2, etc.):

Your actions or failures to act may include but are not limited to the following:

- 1. Requiring masking** can cause medical and emotional harm resulting in oxygen deprivation and depression, among other adverse effects. It is therefore a medical intervention subject to the Nuremberg Code. Although federal, state or other authorities may attempt to mandate masking, xxx School District has an affirmative responsibility to refuse to follow such mandates if following such mandates violates provisions of the Nuremberg Code.
- 2. Voluntary consent (NC 1):** Complete unbiased information has not been provided to the experimental subjects (or their parents/guardians); therefore, voluntary consent has not been sought or given.
- 3. Experimental necessity (NC2):** As an experiment in forced oxygen deprivation and disease prevention, you have provided no protocols detailing durations, necessary CO2 monitoring instruments and protocols, pre- and post-experiment medical examination of subjects, etc. You have not demonstrated that alternatives such as increased air ventilation and purification can obtain the same results, nor have you conducted a relative risk analysis of simply operating without requiring students to wear masks.
- 4. Animal experiment (NC3):** No animal experiments have been performed to study effects of oxygen deprivation prior to the imposition of mask mandates on the children in this district.
- 5. Other violations (NC4 through NC10):** as detailed in the attached Nuremberg Code.

THE NUREMBERG CODE (1947)

Permissible Medical Experiments

The great weight of the evidence before us to the effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, conform to the ethics of the medical profession generally. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.
2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability or death.
8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.
9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.
10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.
